- a. Pete Baird and Mike Wearne had a lunch meeting with Bill Cavender, CPA, and treasurer of the local Lions Club Foundation. Revise R1
  - i. Goal: To discuss Bill Cavender's experience as treasurer of the Lion's club, specifically, how the Lions Club handle donations
    - 1. The Lions have a similar structure as WFFC
      - a. Lions Club = WFFC Club
      - b. Lions Foundation = WFFC Foundation
- b. Suggestion that our WFFC Foundation run the auction to simplify accounting procedures and lines up with IRS rules (at least it would be easier)
- c. Con, Foundation doesn't have the manpower to run the auction. It would need the club to provide the manpower
- d. Suggestions and Comments:
  - i. Let the WFFC club handle the auction (work as a trust account) play close attention to the accounting – What goes from club to foundations and foundation to the club
  - ii. Let the foundation handle the money then send us checks 'for the betterment of the sport' (i.e. education, conservation, special projects)
  - iii. The Lions club dues at \$150 a head carries the expenses of the club, raise WFFC club dues (would have to double them from current) probably not practical since we are in a downward trend of membership
  - iv. If we go the WFFC club route of running the auction, there would be lots of paperwork if we go under audit by IRS highly unlikely but there is some risk
  - v. How important are the 501C3 receipts to the donator, some said this is important, others thought it wasn't "they just write it off"
  - vi. Comment: "We STILL need a Christmas Party VP for 2012 and it's getting awfully late"
- e. Motion Initiated Form a Committee with the goal of investigating and deciding a club/foundation policy, how donations and funds are handled between each organization and which organization will run the auction (this year the club will run the auction)
  - i. This Committee will:
    - a. Include members of both organizations (club/foundation)
    - b. Makeup will include attorneys
    - c. May require some CPA support, only when needed
    - d. Target date for policy formation end of year 2012
      - i. Motion Passed Unanimously
