## **Board Member Reports:**

The site generates mailing labels; consequently, the topic of mailing large items came up because the club would need to figure out how to charge the winner for mailing costs. Additionally several club members offered to deliver within a reasonable radius.

It was decided that it would be open to Club members and their guests.

There was additional discussion re: a live Zoom kick-off and/or a live Zoom closing.

Lengthy discussion resolved that it is a good faith gesture to reach out and see what people would like to do as well as contacting the donors who have offered themselves as guides or cabin stays. Jim offered to reach out to the donors re: extensions.

#### **New Business:**

a Jim Goedhart talked to Bill Neal about the Boyd Aigner fly tying competition. In the past, flies that were submitted were judged by a master fly tyer. It was suggested that 3 judges be selected who would evaluate submissions. Judges would select 1st, 2nd and 3rd place flies. APPROVED

For the Project Healing Waters participants: Neal will talk to Jim McRoberts about picking their flies up.

Pat suggested giving Healing Waters participants materials that they might need. Neal said that most of them have good resources available.

c. Charitable donations: It was suggested that our contributions to various organizations due to the on-going financial situation with COVID.
