BOARD MEMBER REPORTS:

PRESIDENT Danferd Henke

Dan extended a sincere thanks to outgoing officers and trustees. He extended an especially sincere thank you to Jim E, our hard-working Ghillie, who put forth extra effort this past year.

Dan reported that the member survey is complete and has been sent to the committee for review. It will be sent to the club members in early January.

Dan signed the contract with the Seattle Tennis Club for 2024. The club will dine in the Bistro Room and will move to a different room for the presentation. The maximum attendance is stated as 36 people, with the possibility of extending to 40 people if needed. The cost to attend next year's meetings will be \$25. Menu will be a pasta casserole variety.

The club has a booth at the Fly Fishing Show on February 17th and 18th at the Meydenbauer Center in Bellevue. Mike N is taking the lead for planning and organization. Shelley offered to help with volunteer recruitment. Chuck and Tom N offered to volunteer. Chuck has offered to tie flies. Mike has obtained a table, chairs, retractable banner for display of outings information, and a structure for holding the banner up. Mike needs lead time for the club's 2024 outings to be posted on the banner - hoping to get the content set in January. Mike will also finalize the brochure. Mike will rent a stand for the LCD monitor he is providing for the AV presentation which will include a collage of photos and videos of the club's activities. He is still figuring out power options.

<u> TREASURER Kurt Peterson</u>

Kurt reports revenue continues to come in but he has not yet reconciled the financial documents. He has sent an \$8000 deposit to the Seattle Tennis Club. He also paid the bill for the Fly Fishing Show. He will write a check for the foundation. He has made another transfer of \$10,000 into the active account. He reports that, according to the club bylaws, an audit is required within the next few months. He also needs to find someone to do the club's taxes - will ask the membership if anyone is able to provide assistance or a referral. Future actions include revising the policies and procedures to reflect changes in banking practices (policy requires review of actual checks but

images of checks are no longer provided by the bank) and commending an audit in early 2024.

MEMBERSHIP Jim Beck

Jim reported that the club's website has suffered a cyber attack. On November 20th he found 20 bogus membership applications. Soon afterwards, 20 more appeared and continued to grow. By the time the number reached 50, he emailed Dan. Dan contacted the web masters. Jim G worked with IT support to stop membership applications until January 1, 2024. Then a second attack occurred due to second membership link that remained active after the primary link was shut-down. The second link has now been shut-down as well and the attack has stopped.

Chuck worries that potential new members will not get a response and will discontinue their membership application. Dan says this needs to be resolved before the fly fishing show.

Jim G suggests providing new members a discount if signing up at the fly fishing show. Or possibly provide a different incentive such as free first membership dinner or free flies. Primary goal continues to be keeping and engaging new members.
