BOARD MEMBER REPORTS:

PRESIDENT Danferd Henke

Dan extended a warm welcome to new officers and trustees. He also thanks everyone who is continuing in their positions.

The club's monthly meetings are returning to the Seattle Tennis Club venue, beginning this month. Please remind your friends.

Dan reported that the member survey will go out this weekend. Danferd needs to speak to Jim G regarding how to send the survey to former members. Per Jim, a "special" email blast will be needed.

Shelley's suggestion to provide an incentive for people to complete the survey was well received. Neal suggested a private casting lesson as this is something everyone could benefit from. Mike M suggests a nice rod and reel, which may be too personal of an item given specific fly fishing preferences. This will be discussed further at future meetings.

SECRETARY Shelley Scheff and Mike Nolan

The club has a booth at the Fly Fishing Show on February 17th and 18th at the Meydenbauer Center in Bellevue. Mike N has taken the lead for planning and organization, for which Shelley is very grateful. Volunteers are still needed. Shelley is planning to write a brief article regarding the club's involvement in the Fly Fishing Show and request for volunteers to be included in this month's Creel Notes. She will also make an announcement at this month's dinner meeting and send out an email blast to members.

Chuck and Tom N offered to volunteer at the show during the prior month's board meeting. Chuck has offered to tie flies. Jim B also offered to volunteer. Complimentary passes will be provided to those who volunteer. We are aiming for 4 hour shifts, 2 people at the table at a time. Set-up is Friday 12:00 pm - 10:00 pm. Tear down is Sunday at 4:45 pm. Mike has obtained a table, chairs, retractable banner for display of outings information, and a structure for holding the banner up. Mike is working on the outings content for the banner. Mike will also finalize the brochure. Mike has rented a stand for the LCD monitor he is providing for the AV presentation he has created. He has sorted out the power source at the booth location.

TREASURER Kurt Peterson

Kurt provided a financial presentation. The spreadsheets were sent to the board with the agenda for review. The board approved Kurt to pay the Foundation their designated amount from the fundraiser. A refund check from the Seattle Tennis Club came to Kurt but was written to Chapin Henry. Dan will see the WFFC's contact at the Seattle Tennis Club tomorrow and will request that they cut a new check.

Kurt reports that he will be proceeding with the board and committees budgeting process a little differently this year. He will complete the budget, then allow the board and committee members to edit and/or approve the proposed budget. More information regarding this matter will be provided in the future.

MEMBERSHIP Jim Beck

Conservation Robert Thorpe

Robert would like to find a new member to do research and work with Three Rivers TU to present to the legislature. Jim suggests using the website membership filters to find those who expressed interest in conservation.

There is positive national news - the government has stepped away from management of the Snake River Dams. They have also denied a request by Alaska to reopen the Copper River.

There is positive local news - the state is securing funds for the culvert project. There is a bill to allow private groups to fund culverts. Robert will send an email to the club encouraging them to email our representatives regarding this matter.

Robert continues to interact with other local fly fishing clubs. He has also reached out to local tribes.

Robert requests that conservation dollars be directed to Three Rivers TU and Methow Valley Fly Fishing Club. Kurt indicates that Robert will be able to specify where the conservation dollars go when the budget is being determined.
