<u>President</u>

Danferd Henke opened the meeting at 7:04 p.m. with 14 officers and trustees.

Approval of Minutes of March Board Meeting:

The minutes were approved with no updates.



BOARD MEMBER REPORTS:

TREASURER Kurt Peterson

Kurt presented Q1/2023 report. He has provided the check registers for last month. These will be forwarded to the president with the meeting minutes.

MEMBERSHIP Jim Beck

Jim reported that 113 people have paid their membership fees, leaving 40 who have not paid their membership fees. 10 unpaid members have been members of the club for over 10 years. 4 unpaid members have been members of the club for over 5 years. 26 unpaid members are new to the club, having joined last year. Jack Troutman will turn 80 in June and has been a member for 50 years. He is requesting senior status.

Jim and Chapin called everyone on the unpaid list. This effort was marginally successful. Some of the members they contacted have paid their dues. One provided negative feedback regarding the lack of friendliness he experienced at an outing. Some people expressed that they are too old to fish and no longer benefit from membership in the club. Some members found the website too cumbersome. If unable or unwilling to pay on-line, they are welcome to send a check. An inquiry was made if the website could be made more user friendly. Dan said this is in the works but will take time. Jim G said that the website is working fine.

A lively discussion ensued regarding options to recruit new members as well as approaches to make people who are considering membership and/or new members feel more welcome both at meetings and at outings. Robert T suggests allowing members to pay someone else's dues who may be experiencing financial hardship. A specific member's name was brought up and Jim G said he will pay that individual's membership dues. Robert T suggested allowing people under 21 to join. Dan suggests a student membership price. Chuck suggests a periodic "seminar" format at meetings. Chuck suggests name tags at outings. Dan suggests a "welcome banner" at outings. Robert T suggests better signage at outings. Dan suggests that one person needs to take the initiative at outings and be the designated welcoming committee (of one). Please introduce yourself to anyone you don't know, initiate conversation, and welcome them.



Jim reports his primary goal is to maintain current membership, increase engagement of current members, and add new members.

The publicity committee is in progress.

PROGRAMS Neal Hoffberg

Neal reports that monthly meeting speakers have been booked for the year and he is now working on next year. George Pess from NOAA is booked for January, 2024. He will offer a presentation on the Elwa. Unfortunately, only two people signed up for the beginning fly tying class so class was canceled due to low sign-ups. Dick B met with the two people who signed up in order to coordinate individual lessons. Neal offers a perspective about marketing and publicity. He reports that he spoke to a friend and CI in California about what their clubs do for marketing. They have tried newspaper ads, Facebook, and MeetUp but only obtained one new member from those efforts. They have found word-of-mouth to be the most effective.

Beginning casting class starts April 5th in Luther Burbank Park. If anyone is interested in helping, please just stop by.

The FFI event on April 29th is nearly full. WFFC will have a table at that event.

Committee Reports:

<u>Conservation</u> <u>Robert Thorpe</u>

Robert continues to meet with many clubs within the state to discuss conservation matters. These clubs include the Methow Valley Fly Fishing Club as well as 3 Rivers Trout Unlimited club. Robert's son, Brooke, has joined a group at his university to raise money for Healing Waters. They are also planning to do a restoration project on Mercer Island. Neal reminds the group that Project Healing Waters has a volunteer vetting process. Dan sent a request to club members to contact Lone Lake regarding the algae issue. Youth John Gravendyk

13 students have signed up for the youth academy - 2 girls and 11 boys. The goal is 15 students. The cost to cover 15 kids is \$30,000. The organization currently has \$28,000. Molly Seminick will be helping with casting. Blake from Gig Harbor Fly shop will be helping for one day. Our club has donated \$1500 to the Youth Academy and \$1500 to the Mayfly Project. FFI Neal Hoffberg

The FFI Washington State Council Fly Casting Fair will be held on April 29th at Ballinger Lake from 9-4. Many educational opportunities are available including a women's class; kid's class (ages 10-14 years); beginning, intermediate, advanced, and spey casting classes; walk-in casting clinic; fly tying demonstrations; and casting skills workshops.

WFFC Foundation interface Jim Goedhart

Jim G presented a spreadsheet for Foundation donations. Asking for donations to Western Rivers Conservancy (\$2500), NW Youth Fly Fishing Academy Camp (\$1500), and Project Healing Waters (\$1000). Kris Kristoferson also requested a \$2500 donation to Reel Recovery (\$1250 from club + \$1250 Foundation match). A rousing discussion ensued regarding the decision to donate to Reel Recovery or not. Gary provides additional information regarding the mission of Reel Recovery. It is a 2.5 day intensive workshop around fly fishing for people living with cancer. It provides housing, meals, and fellowship. It is a very intense sharing experience and all equipment is provided. The discussion continued and included what types of causes to donate to and what money is earmarked for donation in the budget. It appears that the club has \$6000 extra to spend as we see fit. This is part of a conservation fund that was established 30 years ago. A motion was made to donate the requested funds and was APPROVED!
